Regarding: Notifications on changes in the share in the total number of votes in the Company

Acting on the basis of art. 69 sec. 1 (2) in connection with art. 87 sec. 1 (2) of the Act on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organized Trading, and Public Companies (Journal of Laws of 2005, No. 184, item 1539, as amended), ALTUS Towarzystwo Funduszy Inwestycyjnych S.A. ("ALTUS TFI S.A."), on behalf of investment funds managed by ALTUS TFI S.A., notifies that the funds managed by ALTUS TFI S.A. have decreased their share below the 5% threshold in the total number of votes in Debica S.A. ("Company").

Date and type of events resulting in a change in the notified shareholding:

The decrease in the share in the total number of votes in the Company took place as a result of the acquisition on 4 December 2018 by Rockbridge TFI from ALTUS TFI of the management of the following closed-end investment funds:

- ALTUS FIZ SHARES +,
- ALTUS ASZ FIZ Foreign Markets 2,
- ALTUS FIZ Active Share,
- ALTUS ASZ FIZ Global Opportunities, - ALTUS FIZ Global Actions 2,
- Altus Market Neutral High Dividend FIZ.

Number of shares held prior to the change in shareholding and their percentage share in the Company's share capital, as well as the number of votes attached to the shares and their percentage share in the total number of votes:

Before the change in the total number of votes in the Company, investment funds managed by ALTUS TFI S.A. held a total of 847,812 shares in the Company, constituting 6.14% of the Company's share capital and entitling to exercise 847,812 votes, which constituted 6.14% of the total number of votes in the Company.

The number of shares currently held and their percentage share in the Company's share capital, as well as the number of votes attached to these shares and their percentage share in the total number of votes.

After the change in the total number of votes in the Company, investment funds managed by ALTUS TFI S.A. hold a total of 674,328 shares in the Company, constituting 4.89% of the Company's share capital and entitling to 674,328 votes in the Company, which constitutes 4.89% of the total number of votes in the Company.

The total number of the Company's shares and the number of votes at the Company's General Meeting of Shareholders is 13,802,750.

There are no subsidiaries of the notifying shareholders holding the Company's shares and there are no persons referred to in Article 87(1)(3)(c) of the aforementioned Act in relation to the shareholders. The Notifier does not possess financial instruments referred to in Article 69b(1)(1) and (2) of the Act.
