The Management Board of T.C. Debica S.A., on the grounds of representation made by the Company's Supervisory Board, advises that the Supervisory Board has appointed the auditing firm carrying out the audit of separate annual statement for the financial year 2018 in compliance with effective law, including the appointment of auditing firm and taking into consideration the internal regulations of T.C. Debica S.A. to that extent.

Additionally the Company's Management Board points out that:

- auditing company PricewaterhouseCoopers Sp. z o.o. and members of the team performing the audit of the Company's annual Separate Financial Statement for the financial year 2018 met the conditions for drawing up an impartial and independent audit report on the separate annual financial statements in accordance with applicable regulations, professional standards and ethics;
- The company complies with the applicable laws related to the rotation of the auditing firm and the key statutory auditor and mandatory grace periods;
- the Company has a policy on the appointment of an auditing firm and a policy on providing an
 auditing firm, an entity related to the auditing firm or a member of its network of additional non-audit
 services, including conditionally exempt services from an auditing firm.
