

Agnieszka Joanna Modras: Member of the Supervisory Board, born in 1979. Legal counsel, graduate of the Faculty of Law and Administration at the University of Warsaw, in 2022 she received a doctorate in social sciences in the subject of management science and quality at the Faculty of Management at the University of Warsaw. Between 2002 and 2004, lawyer in the Warsaw office of Weil Gotshal & Manges. Then, in the period from 2004 to 2015, she working as Legal Counsel at Sołtysiński Kawecki & Szlęzak law firm. Between 2015 and 2020 she was a director of the legal service department of Bank Pocztowy S.A. From 2020 till 2023 she was a director of the legal department of Bank Gospodarstwa Krajowego. As of February 2023 she is a Director of PayPo Sp. z o.o. of a Legal and Compliance Department.
